AT&T phone

• Because the VCC does not have a credit history, Rachel was told that we would need a \$1,000 deposit to change over to VCC from Calley Hastings personal account. This is actually a second line off of Judith Irvings account. The phone hardware is needing to be replaced anyway. Eric stated that we just need to list the Board of Directors and show our tax ID number. ACTION: Rachel will contact Diane Bothfeld to see if she can assist with not having to pay the \$1,000 deposit, and we empowered Rachel to press on with AT&T to get this changed.

VT Fresh Network sponsorship to be held on August 9.

- Originally any member of the Council could bring cheese. This changed last year to be only Vermont Fresh members. This is a lot of work for the VCC coordinator. This year Rachel will be away, so she will not be available to set up. ACTION: Rachel will talk with Meghan about having other cheesemakers set up.
- We agreed to sponsor this event for \$250

We are signed up for membership for the ACS for 2011. Rachel will attend the conference in Seattle August 25-28th using the pass we received as part of the membership. We discussed potentially raffling off the membership which is an individual membership worth \$190. Is there a reason for the VCC to be a member? In order to have a corporate membership, it would cost \$950. Mark suggested that we might want to budget for this in the future.

Cheese Festival:

Mark talked about signing Friends for associate membership at the festival and the need to think of the logistics of taking money. Rachel has looked into PayPal account. In return they would receive a poster of VCC members' labels. Other Business:

Logo: Mark has asked the graphic designer for some samples of a new VCC logo. **ACTION**: Mark will try to have the version available for the next meeting.

Mark spoke with Elyssa Clancy about the VCC taking over the eNewsletter. Rachel will begin producing this using the program *Dream Weaver*. **ACTION**: Elyssa has offered to help. Rachel will be meeting with her on May 27.

Our accountant, Chris O'Keefe of Vermont Farm Bureau, has confirmed that we apparently had a \$7,000 CD that turned over. It is somewhat concerning that he was unaware of this. Sebastian now receives a profit and loss statement on request. Because we don't have Mac access, Sebastian cannot drill down on the line items. We need to know more about where the accounts are and decide what is the best thing to do with the money. **ACTION**: Sebastian will buy a copy of *Quicken* so that he will be able to see the detail of each transaction.

Sebastian read the income and expenses. Grafton, Cabot have each sent \$1,000 for ACS event. See Treasurer's Report.
